For Vitreous China:

Winfield Products LLC (below read as Winfield) warrants its china product, excluding plumbing fittings, toilet tank trim products-flush valve, ball cock, and trip lever, (see specific warranty exclusions outlined below for these products) , to be free from defects, in material or workmanship, for the lifetime of this product to the purchaser starting from the date of purchase. Winfield promises to provide a replacement china part for any china part of this product that proves, upon inspection and from the date of purchase, to be defective in material or workmanship. All labor for de-installation and re-installation and transportation costs or charges incidental to warranty service are to be borne by the owner. Winfield provides no warranties, written or oral, beyond those contained on the face hereof.

For Toilet Seat:

All products are guaranteed against defects in material and workmanship for a period of one (1) year from date of purchase.

This guarantee does not apply to any compression molded wood, solid wood, decorator, or economy residential plastic toilet seats used in nonresidential installations, including hotels and motels. This guarantee does not apply to any toilet seats which are modified in any way or used on any type of installation or unit other than conventional water closets. We assume no liability for toilet seats modified or installed on anything other than conventional water closets.

Exclusions:

In no event shall Winfield be liable for incidental or consequential damages and resulting from improper installation or for damages caused by handling, neglect, abuse, misuse or alteration. All implied warranties, including any warranty of fitness for any particular purpose of merchantability, or those that might arise from a course of dealing with the purchaser or usage of trade, are hereby disclaimed or excluded. Winfield warrants its toilets tank trim: ball cock, flush valve, trip lever and plumbing fittings products to be free from defects in material & workmanship for a period of one year from the date of purchase and Winfield promises to provide a replacement toilet tank trim product for any tank trim product and/or plumbing fitting product that proves, upon inspection and within one (1) year from the date of purchase, to be defective in material or workmanship. All labor for de-installation and re-installation and transportation costs or charges are to be borne by the owner. Winfield shall not be responsible or liable for any failure or damage to its toilet tank trim, plumbing fittings or china products caused by the use of either chloramines or high concentration of chlorine, lime/iron sediments and/or other minerals not removed from public water during the treatment of public water supplies or caused by toilet tank type cleaners containing chlorine, calcium hypochlorite and/or other chemicals.
